Registration fees are non-refundable and non-transferable. In case of inclement weather conditions, the start of the race may be delayed. If the event cannot safely proceed, there will be no rain checks or refunds. This event is sanctioned by USATriathlon and will strictly abide by all rules promulgated by that organization, which can be accessed at usatriathlon.org. **If the swim venue is unavailable for any reason, the event will be converted into a sprint duathlon with the swim leg replaced with a 1 mile run followed by 12.5 mile bike, finishing with a 5K run.**

WARNING: READ CAREFULLY.

I understand that participating in this event is potentially hazardous, and that I should not enter and participate unless I am physically and medically able and properly trained.
